A note from Mike Hulefeld, Chief Operating Officer and Fellowship Program Chair

We are inundated each day with television and policy naysayers predicting the worst case healthcare reform doomsday scenario – essentially, a foreshadowing of drastic reimbursement cuts, massive layoffs, and rationing of services for all. As leaders in healthcare, we are more than anxious about the future of our industry, and the overall quality and cost of care provided to our patients. Of course, we know change is inevitable and the old way of doing business is no longer sufficient. However, our anxiety tends to redirect our focus on what is bad rather than what is good in healthcare.

For example, the physicians and staff at Ochsner Hospital for Children recently gave Seth Turner, a boy who just turned 13 years old, a new chance at life. After waiting three years for a heart and having under gone a number of open heart surgeries since the time he was born, Seth received a transplant on June 14th. Although I won't venture to speak for the physicians and staff at the time of the transplant, I can safely assume that Seth's livelihood was their top priority. The facts of Seth's case are unique, but the high quality care that he received is common throughout the Ochsner System. From the diabetes patient who can walk without assistance because his blood sugar is under control, or the mother whose anxiety is lessened after receiving a same-day appointment for her baby with a high fever, these are the issues that represent the good in healthcare. In these times of constant change, I would remind you that we all chose the field of healthcare to make a positive impact in the lives of others. If we concentrate on providing the highest quality care to our patients, then we will readily meet any challenges facing us.

I would also like to acknowledge and welcome our new 2015-2016 administrative fellow class. You will find their pictures and biographies later on in the newsletter. Finance...you either love it or really dislike it, either way, you need someone who can crunch the numbers to stay in balance. Thank goodness for finance people! Well, our Finance Administrative Fellows are an important part of our organization as they bring so much value to the Ochsner family. The Finance Administrative Fellowship provides participants several opportunities to learn about healthcare while utilizing their finance background. The two year Fellowship program offers rotations that focus on core competencies related to medical operations in Decision Support, Revenue Cycle, General Accounting, and direct CFO interaction at several Ochsner locations. After completion of these rotations and departmental designated projects, fellows will have the opportunity to seek out projects that meet their personal career objectives. Professional development is a fundamental component of the fellowship program so fellows are assigned a preceptor who serves as a mentor throughout each rotation. These preceptors are a big part of the success of the program. The fellows are also provided Lean Training during their fellowship, allowing them to be Lean Green Belt certified upon completion. Many of these lean projects have financial components to assist in Ochsner's growth and continued success. In recognition of Ochsner's commitment to Serve, Heal, Lead, Educate, and Innovate, the program provides the fellows the opportunity to continue their education and develop their skills while assisting Ochsner with the market changes and increased cost of care to be a successful health care system for all. As a preceptor myself, I have the opportunity to work directly with the fellows and appreciate their eagerness to learn and grow within the Ochsner organization. Recruitment for the 2015-2017 Finance Fellowship is currently taking place and we look forward to the continued success of the program.

A Former Fellow Shares His Experience...

After graduating from LSU Medical Center in New Orleans with a Bachelor's degree in Rehabilitation Services and the University of Louisiana at Lafayette with an MBA, I had a tough decision to make. I was either going to stay in Management in my current role with Inpatient Rehabilitation hospitals or serve as an Ochsner Clinic Foundation Administrative Fellow. At this point in my career, I consulted with several colleagues and mentors for guidance including two former hospital CEOs who gave me some sound advice which I am still thankful for today. Ultimately, I chose to become an Ochsner fellow, and to this day, I know it was one of the best decisions I've made in my career thus far. When I thought of Ochsner, I thought of the best. I knew that was something I wanted to be a part of.

The Ochsner fellow program affords young healthcare professionals the opportunity to work alongside top-level leaders in a large, integrated healthcare system that is constantly growing, innovating and improving to best meet patient demands and needs in a complex and ever changing industry. Through my fellowship, I explored hospital operations, learned about the inner-workings of a provider owned health plan (OHP), worked with consultants to look at the future of provider owned health plans, and completed a project on reprocessing single-use devices, all the while focusing on financials, project management skills, and physician relations along the way.

As a fellow, I was given the opportunity to attend board meetings, learned how to best work with physicians, and gained a global perspective of the healthcare landscape. The Ochsner fellowship has also opened a number of doors for future growth and opportunities. Shortly after my fellowship, I served in director roles in both clinic and hospital operations at Ochsner Jefferson Highway. I then was given the opportunity to come to Baton Rouge and work as an Assistant Administrator at Ochsner Medical Center – Baton Rouge. This was a unique experience for me as I worked for the joint venture between Ardent Health Services (for profit) and Ochsner. In 2008, I became Chief Operating Officer before earning my current role of Chief Executive Officer for the Baton Rouge Region in 2012.
